Also, be sure to check with your carrier for any additional travel guidelines and/or restrictions.

Parameters may change at any time so continue to stay updated.

- All passengers 18 years and older must present a government or state issued ID with a photograph, such as a driver's license. The passenger's ID and name on their ticket must match exactly.
- Each traveler is required to individually check in his or her own luggage and present a current ID as noted above. Boarding passes will be given at this time and passengers will be asked questions such as: Did you pack your own luggage? Have your bags been left unattended at any time? Did anyone ask you to take a package on board this aircraft?
- Carry-ons must fit under the seat in front of you or in the overhead compartments of the aircraft
- Travel-size liquids, gels and toiletries must be 3 ounce containers or smaller, placed in a 1-quart clear ziploc bag for examination at screening
- Prescription liquid medications, baby formula, baby food and diabetic glucose treatments over 3 ounces must be declared at security checkpoints for examination
- Beverages and other items may be purchased in the secured areas of the airport and taken onboard the aircraft
- Passengers are randomly selected to undergo complete searches, including physical inspection of carryon items and metal or physical detection of that individual
- Airport screeners are taking a closer look at remote control toys in carryon luggage and anyone carrying them due to concerns they can be used as detonation devices
- Disposable razors and plastic/metal scissors less than 4 inches in length with blunt tips are permitted, but knives and blades are not
